As a result of the bid opening held on July 26, 2016 regarding the above referenced project and our review of the Bid documents, we recommend the Town of Tronderoga award the Unit Price Bid Contract to the lowest responsible bidder, Bellemy Construction Company, Inc. In the amount of \$374,000.00, including Alternate No. 2, additional 18" water main via directional drill method, in the amount of \$77,750.00, for a total unit price contract amount of \$451,750.00.
