DECLARATION OF THE AGWAY BUILDING (74 MONTCALM ST) AS A SLUM/BLIGHT SPOT (SBS) AND AUTHORIZATION FOR ESSEX COUNTY LAND BANK TO SEEK CDBG IMMINENT THREAT FUNDING

WHEREAS, the Town of Ticonderoga recognizes the importance of maintaining the aesthetic, structural, and safety standards within our community; and

WHEREAS, the elimination of specific conditions of blight, deterioration, or safety hazards on a spot basis is crucial for the prevention of blight and the protection of adjacent properties or areas; and

WHEREAS, the Agway Building located at 74 Montcalm Street, Ticonderoga, NY (SWIS ID 154800, Tax ID 150.43-7-2.000) has been identified as a significant fire hazard in the downtown area, as confirmed by the Ticonderoga Fire Department, posing a serious and imminent risk to public health and safety; and

WHEREAS, the conditions found at this property are consistent with the definitions for "slum and blight" as set forth by the United States Department of Housing and Urban Development (HUD) in 24 CFR Part 570, specifically qualifying as a Slum/Blight Spot (SBS) due to

its significant deterioration, physical decay, environmental contamination, and safety hazards; and

WHEREAS, the urgent and dangerous conditions at the Agway Building present an imminent threat to the health and safety of residents, businesses, and visitors in the Town of Ticonderoga, requiring immediate action to prevent loss of life, injury, or severe property damage;

WHEREAS, the CDBG Imminent Threat Program provides funding assistance to communities where an urgent condition poses a serious and immediate threat to the health or welfare of the community, and where other financial resources are not available to address the problem; and

WHEREAS, the Essex County Land Bank has expressed interest in applying for funding through the CDBG Imminent Threat Program to support the emergency demolition and clearance of this property;

NOW, THEREFORE, BE IT RESOLVED, that the Town of Ticonderoga hereby declares the Agway Building (74 Montcalm St) a Slum/Blight Spot (SBS) consistent with Federal and State law, and further declares that the property constitutes an imminent threat to public health and safety, requiring emergency intervention; and

BE IT FURTHER RESOLVED, that the Town of Ticonderoga authorizes the Essex County Land Bank to apply for funding through the 2025 CDBG Imminent Threat Program in the amount of **\$1,000,000** to support the emergency demolition of this blighted and hazardous property; and

BE IT FURTHER RESOLVED, that Nicole Justice Green is hereby named the Fair Housing Officer for this project and will ensure compliance with all applicable Federal, State, and local regulations and statutes, including but not limited to:
