Budget Workshop #7 (10/16/2025)

- Working Preliminary Budget
 - Due before the public hearing on 10/23 at our finance meeting.
 - o Reminder: We will adjourn the public hearings on 10/23 until 11/13 regular board meeting.
- Updates Since Last
 - Worker's Compensation: participant contribution rose again for 2026 (see table).
 - We had the highest participant contributions for 2026 of all 18 towns.
 - Town must get these claims under control to save taxpayers money.
 - Keeping on top of issues reduces the chances of claims.
 - This issue alone eats up the 2% tax cap margin (which for us is approx. \$116K).

 - Don't expect final resolution on issues before Preliminary budget is due.

- o 102 Race Track Road Project
 - We have the first pay app but it is incomplete (missing pages 3,4; no signature line for owner).
 - There are possibly TWO change orders. Nothing official submitted to date for approval.
 - CAUTION: These have potential to eliminate any capital reserve for IT, phone, and security tasks.
- o SRT Program: Board stated it would remain in effect for at least one year
 - Finance and PD directed to manually track # of OT per officer.
 - Review again in 2026 to decide whether to continue or cancel participation.
