Mr. Leerkes asked why the larger sign – when this application first came before the board this was only going to be an on-line business with no foot traffic.

Tony Cartiglia agreed, but with what is happening with the tariffs we cannot get our inventory. The area that was a showroom before for Blodgett's has now been turned into a retail store. There will be foot traffic. It is called the Mercantile.

Mr. Leerkes asked what was the issue with the tariffs?

Mr. Cartiglia explained that in order to continue with business we needed to turn to retail. We were selling everything online and we were getting our inventory is from China. At one point our administration made the tariffs 145%, so if we paid 100 thousand for a container, China gets 100 thousand and when it hits our port and the tariff is at 145%, we now have to give our government another 145 thousand. That is something that we cannot afford, and when we order inventory it takes about three months and we cannot budget because we do not know what it is going to cost with how these tariffs are fluctuating. In order to keep this business and keep our employees employed we decided to open up the Mercantile and selling what we currently have for inventory.
